CALL TO ORDER / ROLL CALL

The meeting was called to order by Mayor Peluso at 5:30 p.m. in the Multi-Purpose Room of the Newport Municipal Building at 998 Monmouth Street. The meeting was opened with a moment for silent invocation and the mayor led the Pledge of Allegiance.

PERSONNEL ORDERS

The city clerk read R-2016-040 an order appointing William Darin to the position of Fire/EMS Chief in the City of Newport, effective June 14, 2016. Mr. Fromme introduced and Mr. Darin who began his career in fire service in 1972 and most recently served as Chief in East Peoria, IL. The city clerk read **R-2016-041**, an order authorizing Mayor Jerry Peluso to execute a **contract with Woolpert Engineering** for professional services for the Newport **Riverwalk Improvements / Pedestrian Bridges** Project. Commissioner Peluso made a **motion to approve**

for the purposes of discussion; second to the motion was offered by Commissioner Fennell. Mr. Fromme said the project is a continuation of the Riverwalk Improvements. Pedestrian walkway bridges will connect the Taylor Southgate Bridge with the top of the floodwall. The engineering costs will be \$157,050 of the total project cost of \$1.647m. The project will be administered by Southbank Partners. Future enhancements will include sidewalks all the way to Bellevue along the south side of the floodwall as well. Commissioner Peluso asked for an update to be given in the next few weeks on cleanliness in that area. Mr. Fromme replied the best methods are being researched and we hope to have something in place very soon. Commissioner Fennell said the connections have been talked about for a long time and will be a great link improving accessibility for the river cities. Mr. Fromme agreed and said he hopes there will be an eventual improvement at Columbia Street similar to the pedestrian crossing over the Port of Entry. Another improvement in this area, there has been a lot of damage over the years from those parking behind the aquarium and walking up the floodwall, this will be corrected by the steps being added. Mayor Peluso called for any other questions. Mr. Braun noted the question should be called again since the motion was phrased "for the purpose of discussion". Commissioner Peluso amended his motion to a motion for approve; Commissioner Fennell offered a second. Upon hearing there were no comments or questions, the mayor called for a roll call vote.

Mr. Fromme stated an amendment to the organizational ordinance addressing authorized positions is necessary in order to hire an assistant to the city manager.
