CITY OF NEWPORT, KY MEETING OF THE BOARD OF COMMISSIONERS Monday, April 21, 2014 MINUTES

CALL TO ORDER / ROLL CALL

The meeting was called to order by Mayor Peluso at 7:00 p.m. in the Multi-Purpose Room of the Newport Municipal Building at 998 Monmouth Street. The meeting was opened with a moment for silent invocation and the mayor led the Pledge of Allegiance.

In attendance were: Commissioner Beth Fennell, Thomas Guidugli, Jr., Commissioner, Commissioner John Hayden, Commissioner Frank Peluso, and Mayor Jerry Peluso. Also in attendance were: City Attorney/Acting City Manager Daniel Braun, Chief Tom Collins, Fire Chief Gary Auffart, Assistant City Attorney Robert List, CFO C.R. Wirthlin, Community Liaison Bev Holiday, and City Clerk Amy Able.

PERSONNEL ORDERS

The city clerk read **R-2014-033**, an order **appointing Brett Finnell to the position of Chief Mechanic** in the Public Works Division of the Community Services Department effective April 28, 2014. Commissioner Peluso made a **motion to approve**; second to the motion was offered by Commissioner Guidugli. Commissioner Fennell noted that, though their names are pronounced in the same way, the spelling is different and they are not related. Upon hearing there were no further comments or questions, the mayor called for a roll call vote.

Commissioner Peluso: Yes Commissioner Fennell: Yes Mayor Peluso: Yes Commissioner Hayden: Yes Motion carried 5-0.

The city clerk read **R-2014-034**, an order **appointing Ryan Whaley** to the position of **Firefighter/Medic Grade 0**, in the Newport Fire/EMS Department effective April 22, 2014. Commissioner Guidugli made a **motion to approve**; second to the motion was offered by Commissioner Hayden. Upon hearing there were no further comments or questions, the mayor called for a roll call vote.

Mayor Peluso administered a ceremonial oath to the newest member of the Fire/EMS Department.

PRESENTATIONS

Mr. Ken Lewis played a time-lapsed video and gave an update on the **New Riff Distillery** which will hold a grand opening in two weeks.

Chief Auffart recognized **Ms. Alison Ruebusch**, an employee of Ride the Ducks, for her life saving action and response with an AED in a medical emergency experienced by a guest at Newport Aquarium.

The Mayor called for a brief recess at 7:15 p.m. The meeting resumed at 7:25 p.m. with all members of the Board present.

PUBLIC FORUM

Mr. Kyle Randall reported the West Side had a successful **clean up event** in April and thanked the City for providing supplies.

Mr. Joe Harpin of East Tenth Street offered praise for Josh Tunning, a great community organizer with **Brighton Center** and his enthusiasm stating it is important for local agencies to work together.

Mr. Kevin Cook of West Eighth Street stated a broken curb in the 200 block needs attention.

AUDIT PRESENTATION

Mr. John Chamberlain of Van Gorder Walker gave a presentation reviewing the audit report.

- Looking at internal controls, found no significant deficits or material weaknesses
- A special audit for federal fund expenditures was also done
- Total assets have been relatively steady over the last five years
- Bonds are starting to expire this is beneficial, payments are now \$1.5m less than in 2011
- Unrestricted cash position is starting to stabilize the three month of operating expenses on hand is still a recommended goal, for Newport this amount would be \$4.3m, (currently at \$660,000 which is an improvement) Reserves are improving and there is no longer the level worry seen in 2009
- Looking at revenue and expenditure comparison for governmental funds, management is responding accordingly
- Reviewing assets versus cash for proprietary funds (mainly the Levee) shows total assets decreasing
 each year for depreciation which is normal; cash has increased dramatically, three month reserve
 would be \$1.7m; and the Levee and refuse assets are \$5.2m with \$4.8m restricted
- Regarding the comments in the letter one recommended improvement has already been put into place, since December CFO Wirthlin is producing monthly financial reports
- Consolidated Annual Financial Reports are in CAFRA format
- The Board is reminded of their fiduciary responsibility to review closely for understanding pages 15 through 25, CFO Wirthlin did a good job putting this together
- Basic net position if covered on page 25
 Asset position total roughly \$32m, for business type \$40m, total of \$72m
 Liabilities are \$25.9m governmental, 29.9 for business, total of \$55.8m
- Balance sheet begins on page 27, \$42m assets, \$3.2m liabilities, net \$736,000
- Statement of revenue, expenditures and changes on page 28 shows amounts by fund and then total governmental funds; total revenues of \$17.5m, total expenditures of \$17.3m, excess of revenues over expenditures \$161,000

APPROVAL OF MINUTES

Commissioner Peluso made a motion to approve the minutes of the March 24, 2014 regular meeting; second to the motion was offered by Commissioner Fennell. Upon hearing there were no comments or questions, the mayor called for a roll call vote.

UNFINISHED BUSINESS

Commissioner Peluso made a motion that the second reading of the proposed ordinance on bicycle operation on sidewalks be removed from the agenda and that the matter be added to a future caucus agenda for further discussion. Second to the motion was offered by Commissioner Guidugli. Upon hearing there were no further comments or questions, the mayor called for a roll call vote.

The city clerk gave first reading of tentative number **O-2014-006**, an ordinance amending section 30.042 of the Code of Ordinances concerning meeting agendas. Commissioner Guidugli made a **motion to approve**; second to the motion was offered by Commissioner Peluso. Mr. Braun

explained this is a housekeeping measure following the dissolution of the NCAC; reporting from that organization can be removed from the agenda. Upon hearing there were no comments or questions, the mayor called for a roll call vote.

The city clerk gave second reading of tentative number **O-2014-007**, an ordinance amending section 30.040(a) of the Code of Ordinances concerning the **order of business for regular meetings.** Commissioner Fennell made a **motion to approve**; second to the motion was offered by Commissioner Guidugli. Upon hearing there were no comments or questions, the mayor called for a roll call vote.

Commissioner Fennell: Yes Commissioner Hayden: Yes Mayor Peluso: Yes Commissioner Peluso: Yes Motion carried 5-0.

The city clerk gave second reading of tentative number **O-2014-008**, an ordinance amending section 32.201 of the Code of Ordinances concerning powers and duties of the **Board Of Adjustment** to include variance and appeals procedures from the flood damage prevention ordinance. Commissioner Fennell made a **motion to approve**; second to the motion was offered by Commissioner Peluso. Mr. Braun explained this follows the recent adoption of flood regulations (FEMA FIRM) and makes clear under the duties of the Board of Adjustments that they are the body to hear related variance and appeals matters. Upon hearing there were no comments or questions, the mayor called for a roll call vote.

Commissioner Fennell: Yes Commissioner Guidugli: Yes Mayor Peluso: Yes Commissioner Hayden: Yes Motion carried 5-0.

NEW BUSINESS

The city clerk read **R-2014-035**, a resolution supporting the Regional Trails Alliance Trail Plan. Commissioner Peluso made a **motion to approve**; second to the motion was offered by Commissioner Guidugli. Mr. Braun explained this was requested by Mayor Sherry Carran of Covington. Local governments are showing approval of the regionalized plan by adopting similar resolutions. Upon hearing there were no further comments or questions, the mayor called for a roll call vote.
