Vehicles shall include all standard vehicle equipment and manufacturers warranties and the specified additional options and/or upgrades. Bidder is responsible for transport of all vehicles to the City of Newport, Kentucky.

All sealed bids shall be delivered to City Clerk Amy Able, 998 Monmouth St., Newport, KY 41071 before 10:00 a.m., local time on Thursday, October 12, 2017 at which time the bids will be publicly opened and read aloud. **METHOD OF AWARD**

**QUANTITIES AND LENGTH OF CONTRACT**

This contract is for the delivery of one (1) new 2018 Dodge Charger Pursuit AWD and one (1) new 2018 Jeep Grand Cherokee Laredo 4x4 equipped with specified equipment. All vehicles shall include air conditioning, automatic transmission, power steering, power windows, tilt wheel, AM/FM radio, factory standard full size spare tire, black rims with silver caps, drivers side spot lamp, deactivated rear doors and windows.
